The Department of Law has reviewed the attached regulations of the Alaska Police Standards Council against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Alaska Police Standards Council after the close of the public comment period. The regulations update requirements for the supplying of addresses by police, probation, parole, correctional, and municipal correctional officers, update the definition of "domestic violence" as it relates to those individuals, and comprehensively update the requirements and procedures regarding village police officers (VPOs), including address requirements and a definition of "domestic violence" that correspond to what applies to the other regulated individuals.

Please be aware of two attorney general opinions, one from 1977 and the other from 1984, that may affect the reach of any regulations for village police officers. The definition of "police officer" in AS 18.65.290 is, in most cases, "an employee of the state or a municipal police department." AS 18.65.290(8)(A). The 1977 attorney general concludes that a police department is "an organized civil force whose basic purpose and function is to maintain peace and order and to prevent and investigate criminal offenses." 1977 Op. Att'y Gen. 36, at 7-8 (Sept. 18), 1977 WL 22059 (Alaska A.G.), at 2; *see also* 13 AAC 85.900 (definition of "police department"). The officers must also perform a full range of police duties, defined in AS 18.65.290(8)(A). Working from these definition of "police officer" and "police department," the 1984 opinion states that most, albeit perhaps not all, village police officers are not "police officers" and are outside the reach of Alaska Police Standards Council regulation. *See* 1984 Op.

Att'y Gen. (366-259-84; July 1), 1984 WL 61090 (Alaska A.G.), at 2. Because some second class cities at the time had organized police departments, the 1984 opinion advised that the regulation of village police officers was legal with regard to those communities, and recommended that the council retain regulations in 13 AAC 89. *See id.* at 2-3. But please be aware that the regulations may have limited reach. The council's executive director is aware of the two attorney general opinions.

The December 24, 2019 public notice and the May 8, 2020 certification of adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

BRIEF DESCRIPTION

The Alaska Police Standards Council proposes to adopt regulation changes in Title 13 of the Alaska Administrative Code dealing with basic standards for Village Police Officers, adding a requirement that all officers maintain a current mailing address with the Council and modifying the definition of "crime of domestic violence."

Pursuant to the authority in AS 18.65.220 (1), (2), (3), & (8), the Alaska Police Standards Council proposes to adopt regulation changes in Title 13 of the Alaska Administrative Code, dealing with a requirement for officers and applicants to maintain a current mailing address with the Council; realigning the definition of "crime of domestic violence" with Alaska statutes; clarifying requirements for hiring and training of Village Police officers; increasing the size of a 'village' eligible to hire Village Police Officers from 1000 population to 2000 residents; and, adding definitions to Village Police Officer regulations for "crime of domestic violence" and "good moral character." including the following:

- (1) <u>13 AAC 85.090 and 250 propose changes to add a requirement that an officer keep</u> APSC advised of their current mailing address;
- (2) <u>13 AAC 85.900</u> is proposed to change the definition of "crime of domestic violence" to that defined in AS 18.66.990; and,
- (3) <u>13 AAC 89.010 150</u> propose changes to Village Police Officer regulations including:
 - a) US Citizenship required before hire;
 - b) Clarifying that any felony conviction or a conviction for a domestic violence or a sexual offense defined under AS 12.63.100(7) disqualifies an individual from being hired as a Village Police Officer.
 - c) Adds the illegal use of controlled substances within the past year as a disqualifier (excluding marijuana use).
 - d) A village cannot hire probationary or temporary individuals who do not meet the minimum qualifications.
 - e) Clarifies that an individual who was denied certification or found ineligible for certification is ineligible for hire.
 - f) Requires a village to determine that an applicant meets minimum qualifications and confirm their eligibility with APSC before hire.
 - g) Replaces the VPO training requirements with new, more specific requirements consistent with current academy curriculum and with state statutory requirements such as mandatory training in domestic violence, sexual assault, and dealing with disabled individuals.
 - h) Adding the requirement for Village Police Officers to keep a current address on file with APSC.
 - i) Increases the population size of a "Village" from 1000 residents to 2000;
 - j) Adding definitions to Village Police Officer regulations for "crime of domestic violence" and "good moral character."
