Questions submitted by potential offerors and answers from the state:

Question 1: You reference audio description "with extended time" on line items 6 and 8 of the RFQ. Is this referring to extended audio description, as explained on page 5 of the RFQ and WCAG 2 1.2.7 (https://www.w3.org/WAI/WCAG21/quickref/#extended-audio-description-prerecorded)"?

Response 1: Yes.

Question 2: Is a 1-day turnaround for audio description a requirement of this RFQ?

Response 2: Turnaround times have been amended to reflect a 5-day turnaround time requirement.

Question 3: Is it required to bid on all of these items to be considered as a vendor, or can we bid on specific items as well?

Response 3: Vendor must provide services and quote for all items listed on the RFQ to be considered responsive.

Question 4: Do you have any sense for the amount of content that will need captions and audio descriptions?

Response 4: The State will not guarantee purchasing volume. However, rough estimates of potential use are provided as follows:

Change 2: SEC. III is hereby amended and replaced in full to read:

"III. Deliverables

- 1. Professional captions/transcriptions for video, deliverable within 5 business days with custom caption placement if selected by the State, delivered as downloadable files in a variety of formats including but not limited to VTT, SCC, SRT, TXT.
- 2. Professional audio description files for video, deliverable within 5 business days, with extended time if selected. Files must:
 - a. Be provided as downloadable files with the ability to merge audio description with source media
 - b. Be provided as downloadable files in a variety of formats including, but not limited to MP3, MP4, OGG, WAV.
- 3. A cloud-based platform through which the customer can manage work orders and work product and edit the captions and audio description delivered. The platform should have the following characteristics:
 - a. The ability for the customer to review and edit captions and audio description

- b. Integration with YouTube, so that the customer can order captions and audio description for YouTube videos and publish the completed captions without manual upload and download of video and caption files
- c. Workflow management, allowing the customer to organize files submitted for processing, check the status of work, manage authorized users, and identify a user as a "gatekeeper" to approve work orders before they are submitted to the vendor"

Change 2: SEC. #IX is hereby amended and included in full to read:

"IX. Location of Work

By signature on their Quote, the offeror certifies that all services provided under this contract by the contractor shall be performed in the United States.

If the offeror cannot certify that all work will be performed in the United States, the offeror must contact the procurement officer in writing to request a waiver prior to the deadline.

The request must include a detailed description of the portion of work that will be performed outside the United States, where, by whom, and the reason the waiver is necessary.

Failure to comply with these requirements may cause the state to reject the quote as non-responsive, or cancel the contract."
