Change One: *Delete Section 1.01 in its entirety and replace with the following:*

SEC. 1.01 PURPOSE OF THE ITB

Change Two: Insert the following as a new section.

SEC. 2.05.1 ANTICIPATED AMENDMENTS

During the course of the contract, it is anticipated that some locations identified in Section 2.16 may wish to utilize the contract(s) resulting from this ITB. If the DOT&PF Procurement Officer of Record receives a formal request from the one of the locations identified in Section 2.16, upon mutual agreement with the contractor, the Department of Transportation and Public Facilities reserves the right to amend the contract(s) awarded as a result of this ITB to allow community members in the location to utilize the contract(s) in accordance with the terms and conditions established of the contract being amended.

Change Three: Delete Section 3.15 in its entirety and replace with the following:

SECTION 3.15 PROPOSED PAYMENT PROCEDURES: No payment will be made until the contract is approved by the Commissioner of the Department of Transportation and Public Facilities or the Commissioner's designee. Under no conditions will the state be liable for the payment of any interest charges associated with the cost of the contract. The state is not responsible for and will not pay local, state, or federal taxes. All costs associated with the contract must be stated in U.S. currency.

The Department of Transportation and Public Facilities shall only pay for tests performed on AMHS staff. In the event a contract(s) awarded as a result of this ITB is amended in accordance with Section 2.05.1, the invoicing and payment process shall be determined at the time the amendment is executed. Under no circumstances shall DOT&PF pay for testing services for any non AMHS employee.
