### FINDING OF EMERGENCY

On March 11, 2020, Alaska Governor Mike Dunleavy issued a declaration of public health disaster emergency in response to the COVID-19 anticipated outbreak. The ongoing global, national, and state effects of the COVID 19 response impact school, business, and government shutdowns; as well as redirection of medical services away from routine, administrative, and preventative care services. This has created a hardship in the hiring process for certified public safety positions certified by the Alaska Police Standards Council. Public safety agencies struggle to attract and recruit qualified applicants in normal times; travel and other pandemic health restrictions have made this process even more difficult, resulting in serious staffing shortages within many public safety agencies.

Currently, Alaska Police Standards regulations require an applicant be a United States Citizen to be eligible to be hired in an APSC certifiable position. Recently, the Council learned this regulatory language precludes the hiring of United States Nationals (U.S. Nationals) born in certain Territories of the United States. The Council finds that was not its intent when adopting the regulatory change in 2016 to exclude US Nationals from hire or certification as officers. This exclusion unreasonably limits the applicant pool in times when more applicants are drastically needed. In the last year, APSC has learned of interested applicants who were found ineligible because of their status as a U.S. National.

The Alaska Police Standards Council finds that, in an effort to immediately increase the pool of applicants, and quickly correct an unintended policy restriction, the regulations should be immediately updated to include United States Nationals as applicants eligible to be hired to APSC certifiable positions.

## **ORDER CERTIFYING ADOPTION**

I certify that the Alaska Police Standards Council under the authority of AS 18.65.220, adopted at its August 26, 2020 meeting the attached two pages of regulation changes as an emergency regulation to take effect immediately upon filing by the lieutenant governor, as provided in AS 44.62.180(3).

This action is not expected to require an increased appropriation.

# NOTICE OF ADOPTION OF EMERGENCY REGULATION ON MINIMUM STANDARDS FOR POLICE, VILLAGE POLICE, CORRECTIONS, PROBATION & PAROLE, AND MUNICIPAL CORRECTIONAL OFFICERS OF ALASKA POLICE STANDARDS COUNCIL

On August 26, 2020 the Alaska Police Standards Council adopted, as an emergency regulation, changes in 13 AAC 85.010, 13 AAC 85.210, 13 AAC 85.215 and 13 AAC 89.010 of the Alaska Administrative Code dealing with the inclusion of United States Nationals in officer's eligibility standards, including the following:

- (1) 13 AAC 85.010 is proposed to be changed as follows: Include United States Nationals, in addition to United States Citizens, in standards for hiring of police officers;
- (2) 12 AAC 85.210 is proposed to be changed as follows: Include United States Nationals, in addition to United States Citizens, in standards for hiring of corrections and probation parole officers;
- (3) 13 AAC 85.215 is proposed to be changed as follows: Include United States Nationals, in addition to United States Citizens, in standards for hiring of municipal corrections officers;
- (4) 12 AAC 89.010 is proposed to be changed as follows: Include United States Nationals, in addition to United States Citizens, in standards for hiring of village police officers officers;

The emergency regulation took effect on August 28, 2020 and will expire December 26, 2020. The Alaska Police Standards Council intends to make the emergency regulation permanent.

You may comment on the regulation changes, including the potential costs to private persons of complying with the changes, by submitting written comments to Alaska Police Standards Council, PO Box 111200, Juneau, Alaska 99811-1200, or by dropping them of at 150 3<sup>rd</sup> Street, Juneau, Alaska. Comments also may be submitted through the Alaska Online Public Notice System by accessing this notice on the system and using the comment link. The comments must be received not later than 4:30 PM on October 9, 2020.

You may submit written questions relevant to the proposed action to Alaska Police Standards Council, PO Box 111200, Juneau, Alaska 99811-1200, or by dropping them off at 150 3<sup>rd</sup> Street, Juneau, Alaska. The questions must be received at least 10 days before the end of the public comment period. The Alaska Police Standards Council will aggregate its response to substantially similar questions and make the questions and responses available on the Alaska Online Public Notice System and agency website. The Alaska Police Standards Council may, but is not required to, answer written questions received after the 10-day cut-off date and before the end of the comment period.

# EXCERPT from DRAFT MINUTES OF THE ALASKA POLICE STANDARDS COUNCIL 138<sup>TH</sup> PUBLIC MEETING

## Statewide Teleconference August 26, 2020

## 9. New Business:

## C. US Nationals

Motion was made by Joe White to accept the draft regulation change provided by the Executive Director. Leon Morgan 2<sup>nd</sup>.

#### Discussion:

•••

The Executive Director explained the reason for the discussion about U. S. Nationals' eligibility for hire, and the intent of the proposed emergency regulations change. He recommended adoption on a permanent basis.

Justin Doll- I don't know why we would want to exclude U. S. Nationals. Suggest we move forward with the regulation change and to fix permanently.

Wendi Shackelford- Are there any legal issues to be aware of?

Jack McKenna (DOL)- no, we need to make sure that it is clear as to why this is an emergency requiring the change in regulation.

Justin Doll - do we need to adopt an emergency regulation for this or go right to changing the regulations, or timeframe is too short?

Executive Director - yes, timeframe is too narrow for normal process.

Justin Doll – We can declare COVID emergency is having negative impact on operation by delaying the ability to get U. S. National/U. S. Citizenship sorted out for DOC, and follow up with permanent change.

Jack McKenna - we need to show something that, without the change there would be a lack of corrections officers that provide the necessary public safety through DOC.

- Draft finding of emergency was sent to all council members.

Justin Doll – Let us consider the draft that was sent.

Justin Doll - to DOC- does this create a hardship for DOC to lose staff to this, especially during a time of difficulty in recruiting and instilling positions?

April Wilkerson (DOC) - yes, it does especially when we have brought individuals on and doing well and committed, then to lose them in this fashion. Both work at ACC where it is understaffed at this time- it would be a burden.

Executive Director - this change also is to the eligibility for police officers. It extends the pool of eligible applicants for law enforcement agencies. I've spoken with several agencies who have turned away applicants who are otherwise qualified but are not citizens. This exacerbates the emergency for their staffing. The change would help by expanding the ability for agencies to hire.

The Council needs to also adopt a finding of emergency so we are in compliance with statues that require both a finding of emergency and the adoption of proposed regulation change language.

Joe White moved to amend his motion to include the finding of an emergency justifying the regulation change and to adopt the E.D. draft of the regulation change for U.S. National. Leon Morgan 2nd. Motion passed unanimously.

Motion passed unanimously, by roll call vote.
