**Question 1:** Would you clarify some discrepancies in the specs? In Section 2.10:

Item 14. Jacket, Military Style – Estimated usage is missing Item 24. 3 in 1 Parka – Estimated usage (120) total does not equal the estimated size usage (100) Lot 1 Pants, Sweat - Estimated usage (1500) total does not equal the estimated size usage (500) Shirt, Sweat - Estimated usage (1500) total does not equal the estimated size usage (1400) Lot 2 Pants, BDU - Estimated usage (1700) total does not equal the estimated size usage (1850) Shirts, BDU - Estimated usage (1700) total does not equal the estimated size usage (1850)

Answer 1: Thank you for catching this discrepancy. Below are the answers for each item:

Item 14: Jacket, Military-Style, M65 Storm Jacket – Estimated annual usage is 100, sizing Small to X-Large (65), 2X-Large to 3X-Large (20) and 4X-Large (15). All other specifications as described in the ITB remain the same.

Item 24: 3-in-1 Parka – Estimated annual usage is 100, sizing Small to X-Large (65), 2X-Large to 3X-Large (20) and 4X-Large (15). All other specifications as described in the ITB remain the same.

#### Lot 1

Pants, Sweat – Estimated annual usage is 2000, sizing Small to X-Large (1600), 2X-Large to 3X-Large (300) and 4X-Large (100). All other specifications as described in the ITB remain the same.

Shirt, Sweat - Estimated annual usage is 2000, sizing Small to X-Large (1600), 2X-Large to 3X-Large (300) and 4X-Large (100). All other specifications as described in the ITB remain the same.

Lot 2

Pants, BDU - Estimated annual usage is 1650, sizing X-Small to X-Large (1150), 2X-Large – 3X-Large (365), and 4X-Large (135). All other specifications as described in the ITB remain the same. Shirts, BDU - Estimated annual usage is 1650, sizing X-Small to X-Large (1150), 2X-Large – 3X-Large (365), and 4X-Large (135). All other specifications as described in the ITB remain the same.
