VENDOR QUESTION

- 1) Regarding the period of performance and the return of personnel to the facility. Are reductions in the service expected within this initial period, or will there be an extension and begin reductions in March 2021?

DOC RESPONSE

- 1) The return of personnel and reduction in service is highly unlikely during the initial period of the contract (Dec 2020 to Feb 2021) Beginning in March 2021 it will become slightly more likely that a reduction in service will be necessary, and the probability will rise with each renewal of the contract. The actual dates are not known at this time.

VENDOR QUESTION

- 2) Is there an incumbent currently providing this service? When was the contract awarded?

DOC RESPONSE

- 2) Currently, Guardian Security is providing guard service to Palmer Correctional Center and the contract was awarded May 1, 2018.

- 3) What is the reason for this solicitation (i.e., expiring contract, etc)?

DOC RESPONSE

- 3) Our current contract with Guardian Security is expiring at the end of November 2020.

- 4) Will you provide the current bill rate for the incumbent service?
