Title 7 Health and Social Services.**Chapter 105. Medicaid Provider and Recipient Participation.****7 AAC 105.230. Requirements for provider records.**

7 AAC 105.230(f) is amended to read:

(f) A provider who maintains all or part of the provider's records in an electronic format shall ensure that the data required to be maintained by this section is available and accessible **under this chapter or** if requested under 7 AAC 105.240(a). **The electronic records include the use of an electronic visit verification system required under 7 AAC 125.070 and 127.053.**

Chapter 125. Medicaid Coverage; Personal Care Services and Home Health Care Services.

7 AAC 125 is amended by adding a new section to read:

7 AAC 125.070. Electronic visit verification. (a) A provider of personal care services is required to use an electronic visit verification (EVV) system that is either provided or approved by the department. If a provider decides to use its own EVV system or vendor, that system must include the following data at the time of service delivery and report to the state's EVV system:

- (1) name of the agency;
- (2) identity of the rendering provider;
- (3) identity of the recipient;
- (4) location of the service;
- (5) date of the service;
- (6) start and stop times of the service; and
- (7) type of service provided.

(b) A provider of personal care services

(1) may not submit a claim for payment under 7 AAC 125 Personal Care without also submitting the EVV data to support each claim; and

(2) must affirm the accuracy of each EVV submission, review and resolve, at least every quarter, any exceptions in the EVV system they use, and

(3) must repay to the department any identified overpayment within 90 days;

(4) must coordinate and upload all aggregate data into the department's EVV system on a daily basis or at another frequency specified by the department, if the provider is not using the department's EVV system.

(c) for purposes of this section, "EVV" means electronic visit verification.

7 AAC 127 is amended by adding a new section to read:

7 AAC 127.053. Electronic visit verification. (a) A provider of Community First Choice personal care services is required to use an electronic visit verification (EVV) system that is either provided or approved by the department. If a provider decides to use its own EVV system or vendor, that system must include the following data at the time of service delivery and report to the state's EVV system:

- (1) name of the agency;
- (2) identity of the rendering provider;
- (3) identity of the recipient;
- (4) location of the service;
- (5) date of the service;
- (6) start and stop times of the service; and
- (7) type of service provided.

(b) A provider of Community First Choice personal care services

- (1) may not submit a claim for payment under 7 AAC 127 Community First Choice personal care services without also submitting the EVV data to support each claim; and
- (2) must affirm the accuracy of each EVV submission, review and resolve, at least every quarter, any exceptions in the EVV system they use, and
- (3) must repay to the department any identified overpayment within 90 days;

(4) must coordinate and upload all aggregate data into the department's EVV system on a daily basis or at another frequency specified by the department, if the provider is not using the department's EVV system.

(c) for purposes of this section, "EVV" means electronic visit verification.
