SUBJECT: Corrections to the Alaska
Administrative Code (AAC):
article numbers for 7 AAC 110,
Articles 14 - 18

In accordance with the authority of the regulations attorney under AS 44.62.125(b), please forward to the publisher the corrections to the Alaska Administrative Code (AAC) described below. I have forwarded these corrections under a specific delegation dated March 23, 2020 from the regulations attorney. These revisions correct a manifest printing errors in the numbering of articles.

The article numbering to be revised is in 7 AAC 110, as amended to add 7 AAC 110.575 on July 8, 2020, to appear in Register 235 (October 2020). One of the printing error appears in the public electronic database; we expect that the error is reproduced in the internal FOLIO database and in the Register 235 AAC supplements that have shipped. The other printing error already appears in the printed Alaska Administrative Code, the public electronic database, and our internal electronic database.

Rather than provide a confusing explanation about how the errors came to be, I will simply specify which sections should be assigned to which article:

--7 AAC 110.565 (clinical social work services): please assign to (new) Article 14 (clinical social worker services);

--7 AAC 110.575 (marital and family therapy services): please assign to (new) Article 15 (marital and family therapy services); fix the numerical order of sections so that 7 AAC 110.575 precedes, rather than follows, 7 AAC 110.600;

--7 AAC 110.600 (targeted case management for children with disabilities): assigned to (existing but renumbered) Article 16 (targeted case management), and *follows* 7 AAC 110.575;

--7 AAC 110.620 - 7 AAC 110.639: assigned to (existing but renumbered) Article 17 (telemedicine);

--7 AAC 110.700 - 7 AAC 110.715: assigned to (existing but renumbered) Article 18 (vision care services).

In the public and internal FOLIO databases, please request that the publisher resolve the incorrect article groupings.

One set of errors already is set out in the printed version of the Alaska Administrative Code. If, as we expect, the other set of errors appears in the official print version of Register 235, please request that the publisher resolve the incorrect article groupings in the Register 236 supplement (January 2021).
