The Department of Law has reviewed the attached regulations of the Department of Labor and Workforce Development and the Alaska Workers' Compensation Board against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Labor and Workforce Development and the Alaska Workers' Compensation Board after the close of the public comment period. Reflecting AS 23.30.240, as repealed and reenacted under sec. 18, ch. 91, SLA 2018 (SCS CSHB 79(FIN)), the regulations clarify the types of ownership interests of corporate officers and members of limited liability companies that would not make those persons employees.

The August 31, 2020 public notice, the November 10, 2020 certification of adoption order from the Alaska Workers' Compensation Board, and the November 13, 2020 adoption order from the Department of Labor and Workforce Development all state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

We have made some technical corrections to conform the regulations in accordance with AS 44.62.125. The corrections are shown on the attached copy of the regulations.
