This Advisory provides for an amendment to the Information For Sealed Bids document.

 A question from a prospective bidder requires that DOT&PF extend the Sealed Bid Due Date in order to provide an answer to their question, which will affect how bids are submitted and evaluated. The Sealed Bid Due Date is hereby amended to before 3:00pm, Alaska Prevailing Time, January 13, 2021.

The following date is also amended in the Instructions to Bidders paragraph #4 – Bid Deposit:

Any Bid Deposit submitted must be received by the State of Alaska no later than 3:00pm, Alaska Prevailing Time, January 13, 2021.

 Attachment #A-3 (Sealed Bid Form CHE + FWX) is hereby deleted from Invitation For Sealed Bids #2521S019.

Bidders will only submit Attachments A-1 – Sealed Bid Form CHE and/or Attachment A-2 – Sealed Bid Form FWX with their bid package.

- 3. Evaluation of Bids: Bids will be evaluated as follows:
  - If a bidder submits Sealed Bid Form A1 (CHE) and/or Sealed Bid Form A2 (FWX) only and does not submit Sealed Bid Form A3, the price offered on A1 or A2 shall be the evaluated price for A1 or A2.
  - If a bidder submits A3 only and does not submit A1 or A2, the bidder must submit A1 and A2. Under this scenario, A3 shall be withdrawn from consideration as the price offered on A1 and A2 as submitted shall be the evaluated price for A1 and A2.

If the bidder chooses not to submit A1 and A2 as described in this section, the price offered on A3 shall be divided by 2 to equal the offered price for each vessel. The offered price for each vessel shall be evaluated individually for A1 and A2.

• If a bidder submits A1, A2, and A3, the prices offered on A1 and A2 shall prevail. Under this scenario, A3 will be disregarded and will not be considered as the prices offered on A1 and A2 shall be the evaluated prices.

Bids will be awarded based upon the following language in the fourth paragraph on page number one (1) of the IFSB:

"The Department has established reserve prices for the sale of the FVF Chenega and the FVF Fairweather. This value is not being disclosed to interested parties during this advertisement. The value will be announced at the sealed bid opening. The Department will sell the (A-1) FVF Chenega and (A-2) FVF Fairweather to the highest bidder(s) at or above the reserve prices. The Department reserves the right through this notice to negotiate with the highest bidder, if the Department does not receive any bids at or above the reserve prices."
