Mining Regulations, Title 11, Alaska Administrative Code Opportunity to Comment on Proposed Regulations

Dear Alaskan:

The Department of Natural Resources (DNR) is proposing to revise regulations concerning mining rights in Title 11 of the Alaska Administrative Code. I am writing to explain the proposed regulation changes, why we are proposing this regulation package now, and how this action relates to the ongoing resource management planning process. I invite you to review and comment on these proposed regulations.

Brief Description

DNR is proposing to revise regulations in response to the passage of Senate Bill (SB) 155 (SLA 2020, Chapter 31). The legislative and public scoping processes have assisted DNR in identifying regulation revisions to implement SB 155 relating to the following topics:

- Applicability
- Locations
- Qualifications
- MTRSC and traditional mining claims and leasehold locations
- Certificate of location and first rental payment
- Annual Labor
- Abandonment, relinquishment, and relocation
- Definitions

Why Do We Need These Regulations Now?

DNR is required to amend regulations in Title 11 to implement SB 155 relating to exploration and mining rights; annual labor requirements with respect to mining claims and related leases; statements of annual labor; providing a definition of 'labor'; and providing for an effective date of March 30, 2021. Opportunity for Comment

Interested parties are encouraged to review the proposed regulations and submit any comments to the Division of Mining, Land and Water. Enclosed is the official "Notice of Proposed Changes on Mining Rights in the Regulations of the Department of Natural Resources," which lists the specific areas and provides the details regarding the submission of public comment.
