The Department of Law has reviewed the attached regulations of the Department of Administration against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Administration after the close of the public comment period. The regulations concern the display of a state or United States Coast Guard number on a boat, boat titles, certificates, and registration, reporting requirements regarding motor vehicles, off-highway restricted non-commercial driver's licenses, compliance with federal training requirements for obtaining commercial driver's licenses (CDLs), requirements for holders of CDLs to report convictions of violations of motor vehicle laws, the extension of the expiration of a driver's license for residents in military or certain other forms of other government service and for spouses of those residents, fees for driver's records, verification Honorable Kevin Meyer, Lieutenant Governor File No. 2020200363

of motor vehicle insurance, requirements for self-insurers, and requirements for an insurance company obtaining title to an unrepairable--i.e., "junked" or "totaled"--vehicle.

The July 13, 2020 public notice and the February 16, 2021 adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

BRIEF DESCRIPTION

The Division of Motor vehicles proposes to change regulations in Title 2, Chapters 70, 90, and 92 of the Alaska Administrative Code, dealing with content on display of boat numbers, boat record fees, submission of crash reports, Off-Highway driver's licenses, federal Entry Level Driver Training requirements for commercial learner's permits and commercial driver's licenses, driver license extension for United States Foreign Service Personnel and volunteers of the United States government, driving record fees, methods of insurance verification, self-insurers, and branding of vehicles junked by an insurance company, including the following

- (1) 2 AAC 70.020, 2 AAC 70.030, are proposed to be amended with additions regarding boats documented by the United States Coast Guard.
- (2) 2 AAC 70.200 and 2 AAC 70.210 are proposed to be amended to increase the notification timeframe for a change of address for a boat, consistent with vehicle and license notification timeframes and wording changes to retroactively comply with the new boat titling requirements in AS 05.25.055 and AS 05.25.056 that took effect January 1, 2019.
- (3) 2 AAC 70 is proposed to be amended to add a new section dealing with release of boat records and boat record fees.
- (4) 2 AAC 90.110, 2 AAC 90.240, and 2 AAC 90.510, including the Editor's Notes, are proposed to be amended to update both the division office location and address where a crash report can be submitted.
- (5) 2 AAC 90.220 is proposed to be amended to change the criteria for waiving the road skills test for a non-commercial driver's license in an off highway area of the state from "no DMV access for road testing" to "without land-connected road access to a location where the road test is conducted at least once every 12 months".
- (6) 2 AAC 90.430 is proposed to be amended to include Alaska residents who are United States Foreign Service Personnel and volunteers of the United States Government as eligible for a driver's license extension. A new section is proposed to be added to clarify when a new card displaying a future expiration date may be
