**Chapter 14. Board of Certified Direct-Entry Midwives.**

The emergency adoption of 12 AAC 14.125 is made permanent to read:

**12 AAC 14.125. Emergency courtesy license.** (a) In an urgent situation, the board may issue an emergency courtesy license to practice as a direct-entry midwife to an applicant who has a license in good standing to practice direct-entry midwifery in another jurisdiction with licensing requirements at least equivalent to those of this state, and who meets the requirements of this section. The board may limit the scope of a license issued under this section, as appropriate to respond to the urgent situation.

(b) An applicant for an emergency courtesy license under this section must submit to the department a completed application on a form provided by the department. A complete application includes

- (1) the applicable application and licensing fees established in 12 AAC 02.145;
- (2) verification of a current license in good standing to practice direct-entry midwifery in another state or other jurisdiction;
- (3) certification that the applicant is not the subject of an unresolved complaint or disciplinary action before a regulatory authority in any jurisdiction;
- (4) evidence satisfactory to the board that the applicant has not engaged in conduct that is ground for imposing disciplinary sanctions under AS 08.65.110;
- (5) certification that the applicant has completed a course of study and supervised clinical experience of at least one year's duration, and has passed the national examination required of certified direct-entry midwives in this state.

(c) An emergency courtesy license issued under this section is valid for the period specified by the board and may not exceed 120 consecutive days.

(d) While practicing under an emergency courtesy license issued under this section, the holder of the license must comply with the standards of practice set out in AS 08.65 and this chapter and is subject to discipline for actions taken or omitted while practicing under the emergency courtesy license.

(e) The board may refuse to issue an emergency courtesy license for the same reasons that it may deny, suspend, or revoke a license under AS 08.65.110.

(f) In this section, "urgent situation" means a health crisis that requires increased availability of direct-entry midwives. (Eff. 12/3/2020, Register 237)



The Department of Law has reviewed, against the statutory standards of the Administrative Procedure Act, the attached emergency regulations that the Board of Certified Direct-Entry Midwives intends to make permanent. Based upon our review, we find no legal problems. The emergency regulations were adopted on November 10, 2020, and were filed and took effect on December 3, 2020. The Board of Certified Direct-Entry Midwives action to make the regulations permanent occurred on February 10, 2021, after the state legislative session began. *The emergency regulations will expire on April 1, 2021 unless made permanent.*

This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The emergency regulations were approved by the Board of Certified Direct-Entry Midwives, after the close of the public comment period, as permanent regulations. To increase the availability of direct-entry midwifery services during the COVID-19 pandemic and future health crises, the regulations provide for emergency courtesy licenses in urgent situations.

The November 16, 2020 certification of adoption order, the December 6, 2020 public notice, and the February 10, 2021 certification of compliance all state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

**BRIEF DESCRIPTION:** The Board of Certified Direct-Entry Midwives proposes to make permanent regulation changes made by emergency regulation regarding emergency courtesy license.

On **November 10, 2020**, the Board of Certified Direct-Entry Midwives (Board) adopted, as an emergency regulation, changes in 12 AAC 14 of the Alaska Administrative Code dealing with emergency courtesy license, including the following:

**12 AAC 14.125. Emergency courtesy license**, is a proposed new section to allow for an emergency courtesy license for direct-entry midwives, specific to the public health emergency or crisis due to COVID-19 pandemic.

The emergency regulation took effect on **December 3, 2020**, and will expire **April 2, 2021** unless made permanent. The Board intends to make the emergency regulation permanent.





**Agenda Item #5 – Emergency Courtesy License**

RLS Derr directed the board to the next item on the agenda, the Emergency Courtesy License Regulations. The board reviewed the documents and there were no public comments received. The board clarified the cost of the ECL and the length it would be active, it was agreed this is an effective way to assist the profession and Alaskan's in an emergency.

**A motion was made to move 12 AAC 14.125 Emergency Courtesy License as presented and make permanent by Rachel Pugh; seconded by Hannah St. George, and the motion passed unanimously.**

## FINDING OF EMERGENCY

The Board of Certified Direct-Entry Midwives finds that an emergency exists under AS 44.62.250, and that an emergency regulation change is necessary to 12 AAC 14, dealing with emergency courtesy license, requiring regulations to enable additional direct-entry midwives services to be quickly available in the state, for the immediate preservation of the public peace, health, safety, or general welfare. The facts constituting the emergency include the following:

Facilities are unable to maintain staffing levels due to the current and ongoing spike in COVID-19 hospitalizations and the increase in medical staff unable to report to work due to COVID-positive tests, quarantine awaiting test results, or caring for a COVID-positive relative—especially in rural areas and in facilities serving special needs populations. The commissioner of the Department of Health and Social Services has specifically requested health care boards implement emergency measures to allow qualified providers in other jurisdictions to become licensed quickly in Alaska to fill these gaps.

## ORDER CERTIFYING ADOPTION

- (1) the applicable application and licensing fees established in 12 AAC 02.145;
- (2) verification of a current license in good standing to practice direct-entry midwifery in another state or other jurisdiction;
- (3) certification that the applicant is not the subject of an unresolved complaint or disciplinary action before a regulatory authority in any jurisdiction;
- (4) evidence satisfactory to the board that the applicant has not engaged in conduct that is ground for imposing disciplinary sanctions under AS 08.65.110;
- (5) certification that the applicant has completed a course of study and supervised clinical experience of at least one year's duration, and has passed the national examination required of certified direct-entry midwives in this state.

(c) An emergency courtesy license issued under this section is valid for the period

specified by the board and may not exceed 120 consecutive days.

(d) While practicing under an emergency courtesy license issued under this section, the holder of the license must comply with the standards of practice set out in AS 08.65 and this chapter and is subject to discipline for actions taken or omitted while practicing under the emergency courtesy license.

(e) The board may refuse to issue an emergency courtesy license for the same reasons that it may deny, suspend, or revoke a license under AS 08.65.110.

(f) In this section, "urgent situation" means a health crisis that requires increased availability of direct-entry midwives. (Eff. 12 / 3 / 2020, Register 237)
