The Department of Law has reviewed the attached regulations of the Alaska Permanent Fund Corporation Board and submits them for publication in the Alaska Administrative Code. Under AS 37.13.120(a), the APFC Board of Trustees ("Board") "shall adopt regulations specifically designating the types of income-producing investments eligible for investment of fund assets." This regulation is within the Board's statutory authority. A regulation adopted by the Board is not subject to the provisions of AS 44.62 – the Administrative Procedure Act. Instead, public notice requirements for the adoption, amendment, or repeal of a regulations are found at AS 37.13.206(c)-(e). The board satisfied these requirements prior to adoption of the regulation. No public comments were made in response to this regulation package.

Under AS 37.13.206(g), a regulation adopted by the Board becomes effective immediately upon its adoption. The Board adopted the proposed regulation related to real estate investments on February 18, 2021 to be effective upon adoption. *Accordingly, the regulations should reflect an effective date of February 18, 2021*.

We have made a technical conforming amendment to 15 AAC 37.430(a)(20) to reflect the citation changes caused by the repeal and re-adoption of 15 AAC 137.450. These technical edits were reviewed and approved by the corporation's legal counsel.
