The Department of Law has reviewed the attached regulations of the Alaska Commission on Postsecondary Education against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Alaska Commission on Postsecondary Education after the close of the public comment period. To meet requirements imposed on member states by the National Council for State Authorization Reciprocity Agreements (NC-SARA), the regulations take the existing dispute resolution process for postsecondary educational institutions denied exemption from AS 14.48, and offer that process, with program-specific variations, to institutions denied approval to operate under the Western Interstate Commission for Higher Education State Authorization Reciprocity Agreements (W-SARA).

The November 30, 2020 public notice and the January 26, 2021 certification of adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.
