PROJECT NAME: LAS 33544

GEOGRAPHIC LOCATION: A cross-country travel route, located in southcentral Alaska, approximately 60 miles northeast of Palmer in the Talkeetna Mountains. From MP 123 Glenn Highway, the requested route travels northwest along RST 1426 Belanger Pass, travels west along RST 433 Caribou Creek for approximately 10 miles to access a private parcel.

#### LEGAL DESCRIPTION:

Sections 1 and 12, Township 21 North, Range 11 East, Seward Meridian  
Sections 7, 17, and 18, Township 21 North, Range 12 East, Seward Meridian  
Sections 25, 26, 27, 35, and 36, Township 22 North, Range 11 East, Seward Meridian

REQUESTED ACTIVITY: Applicants Rick and Claudia Dolfi are requesting an amendment for the addition of a seasonal route (May through October) for movement of heavy equipment for one small dozer to a private parcel, in addition to their authorized winter seasonal route.
