The Department of Law has reviewed the attached regulations of the Department of Health and Social Services against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. The regulations were adopted by the Department of Health and Social Services after the close of the public comment period. The agency has requested that these regulations be in effect on or before July 1, 2021; so that they take effect on the requested date, we request that the regulations be filed on or before May 28, 2021.

The regulations make amendments to Medicaid coverage and payment provisions for behavioral health services, to comply with the state's corrective action plan with the United States Department of Health and Human Services, Centers for Medicare and Medicaid Services (CMS). The regulations include the repeal of specific rehabilitative services from current regulations, amendments to reflect the transition to Medicaid behavioral health services available as "section 1115" waiver services under 42 U.S.C. 1315(a), and related conforming changes.
