7. Estimated annual cost to comply with the proposed action to: The Alaska Commission on Postsecondary Education fees for authorizations, amendments, agents, and exemptions of authorization. Current fees do not allow for sufficient cost recovery for the program for authorizing and compliance. The proposed revisions to fees are based on a fee study that evaluated staff time, in accordance with AS 14.48.

A private person: \$250 increase for initial authorization; creation of range between \$400 and \$1000 for annual reporting; removal of fee for renewal of authorization; a \$150 increase for exemption of authorization; \$650 increase for program amendment, mission change or change in status requiring Commission action, or an addition of a new program; a \$250 increase in late fee for authorization or annual report; creation of \$200 administrative determination, and \$250 increase for additional site inspection.
