Specifically this contract includes:

PARKING LOTS

- Snowplowing, Snow Removal and Sanding Services at the Kenai Courthouse which includes: All parking lots, and access driveways.
- Snowplow areas include the entire area of parking lots and driveways as identified on Attachment A site plan.
- All areas in the contract must be cleared of snow, and sanded or ice free by 7:30 am each day.
- Contractor shall automatically plow and remove snow as needed upon accumulation of 2" or more in a 24 hour period.
- If conditions become icy from 7 am to 6 pm; contractor will, w/in 2 hrs from call-out, provide sanding services.
- Court may request call-out for icy conditions during the day.
- Classes of equipment and sanding materials are specified in the Technical Requirements.
 SIDEWALKS, STAIRS, RAMPS ENTRYWAYS AND EXITS
- Shoveling and Removal of snow from all areas which include: sidewalks, stairs, ramps, entryways and exits.
- Shoveling areas are identified on Attachment B site plan.
- All areas in the contract must be cleared of snow, and sanded or ice free by 7:30 am each day.
- Contractor shall automatically plow and remove snow as needed upon accumulation of 2" or more in a 24 hour period.
- Shoveling services shall also be provided during the weekdays 7:30 a.m. to 5:00 p.m. when snow or ice is actively accumulating (2" or more), once at 11:00 a.m. and once at 4:00 p.m.
- Court may request call-out at other times as necessary, such as when high winds cause snow drifting.
- Contractor will apply ice melt to sidewalks, steps, ramps and building entries and exits to prevent slip and fall conditions.

Performance Period and Conditions are specified in the ITB.

- Contract Period commences on October 15, 2021, and expires on April 15, 2022.
- Employee of Contract must be physically located in the Kenai/Soldotna area.
- Minimum call-out time is 2 hours, inclusive of travel time.
- Dump site shall be no farther than 5 miles from courthouse.

Insurance requirements are specified and include: Worker's compensation Insurance per statutory minimums, but not less than \$100,000 per person, \$100,000 per occurrence., General Liability with coverage not less than \$500,000 combined single limit per occurrence; and Automobile Liability Insurance no less than \$100,000 per person; \$300,000 per occurrence bodily injury; and \$50,000 property damage.

- Invoice is on an itemized basis per inches of snowfall and on a per occurrence basis for sanding and applying ice melt.
- We follow the State of AK Procurement Guidelines September 25, 2013.
- The Documents required for the bid are the Bid Schedule, including acknowledgement of any addenda. A Bid Guarantee (5% of Total Bid Price) is required. Copy of a valid Alaska Business License.
