


Population Deviations

"Each [house district] shall contain a population **as near as practicable** to the quotient obtained by dividing the population of the state by forty." Article VI § 6.

"[T]he Alaska Supreme Court acknowledged that in urban areas in particular the population is sufficiently dense and evenly spread to allow **minimal population deviations**, especially in light of the newly available technological advances."


