IMPORTANT NOTICE: If you downloaded this solicitation from the State's Website, you must register with the Central Region Plans room to be placed on the planholders list and to receive subsequent addenda. Failure to register may adversely affect your proposal. It is the Offeror's responsibility to insure that he has received all addenda affecting this RFP. To be registered, call, email, or fax and provide the project name & number, company name & contact person, address, phone number & fax number.

SELECTION PROCEDURE

1. Competitive Sealed Proposals will be evaluated by a committee (2 AAC 12, Article 4). Evaluation of responses to criteria set forth in Part C results in a numerical score for each proposal. Each criterion in Part C has an assigned weight for this RFP which demonstrates its relative importance. The total of all weights is 100 (100%). Each one-percent weight equates to a range of 0-5 points per Evaluator. The maximum points (score) obtainable for any proposal is equal to the product of 500 multiplied by the number of Evaluators.
2. Scoring of proposals will be accomplished as follows:
 - 2.1 Each Evaluator will individually read and rate each Offeror's response to each criterion described in Part C - Section I - Technical Proposal. Ratings will be based solely on contents of proposal and in compliance with the Contracting Agency's standard Instructions for Evaluation Committee. Except as may be stated within any criterion description in Part C, a rating of "5" = Best Response from all Offerors; "4" to "1" = Progressively Less Responsive; "0" = Non-Responsive. Ratings are multiplied by the assigned weights for each criterion to obtain criteria scores.
 - 2.2 After completion of individual ratings in Part C, Section 1, Technical Proposal, the Evaluation Committee will meet to discuss proposals. Evaluators may then alter their ratings; however, any changes shall be based solely on the criteria set forth in Part C.
 - 2.2 After scoring Part C - Section I - Technical Proposal, criteria scores for Part C - Section II - Preferences, and Section III - Price (if applicable), will be calculated based on criteria descriptions.
 - 2.4 The total score for each Offeror will be obtained by summing the scores determined for each criterion in Sections I, II and III of Part C. The order of ranking for negotiations shall be as follows: highest scored Offeror will be ranked first, next highest scored second, and etcetera.
3. Evaluators may discuss factual knowledge of, and may investigate Offerors' and proposed Subcontractors' prior work experience and performance, including projects referenced in proposal, available written evaluations, etcetera, and may contact listed references or other persons knowledgeable of a Contractor's and/or a Subcontractor's past performance. Factors such as overall experience relative to the proposed contract, quality of work, control of cost, and ability to meet schedules may be addressed. If any issues of significant concern to the proposed contract are discovered, the Committee may:
 - 3.1 Provide written recommendations for consideration during contract negotiations;
 - 3.2 Conduct discussions in accordance with paragraph 4, below.
4. The Committee may decide to conduct discussions (or "interviews") with responsible Offerors whose proposals are determined to be reasonably susceptible of being selected for award for the purpose of clarification to assure full understanding of, and responsiveness to, the solicitation requirements (AS 36.30.240 & 2 AAC 12.290). Offerors selected by the Committee for discussions may be permitted to submit Best and Final Offers (BAFO) for final Committee Evaluation. After discussions and any BAFO's, Evaluators will determine the final scoring and ranking for contract negotiations by evaluating written and oral responses using only the criteria set forth in Part C of this RFP (2 AAC 12.260(b)).
5. All Offerors will be advised of the Offeror selected for negotiation and, after completion of negotiations, a Notice of Intent to Award will be provided to all Offerors. If contract negotiations are unsuccessful with Offeror(s) selected for negotiation, the Contracting Agency may either cancel the solicitation or negotiate with other Offerors in the order of ranking.

3. Offerors are specifically advised that a contract shall not be in effect until a written agreement is executed by an authorized agent of the Contracting Agency. The Contracting Agency shall not be liable for any cost incurred by an Offeror in response to this solicitation, including any work done, even in good faith, prior to execution of a contract and issuance of a Notice to Proceed.

4. The Contracting Agency expressly reserves the right to waive minor informalities, negotiate changes or reject any and all proposals and to not award the proposed contract, if in its best interest. "Minor Informalities" means matters of form rather than substance which are evident from the submittal, or are insignificant matters that have a negligible effect on price, quantity, quality, delivery, or contractual conditions and can be waived or corrected without prejudice to other Offerors (2 AAC 12.990).

5. All proposals shall be open for public inspection (AS 36.30.230) after a Notice of Intent to Award is issued. Offerors should not include proprietary information in proposals if such information should not be disclosed to the public. Any language within a submittal purporting to render all or portions of a proposal confidential will be disregarded. Proprietary information which may be provided after selection for contract negotiations will be confidential if expressly agreed to by the Contracting Agency (AS 36.30.230).

6. Substitution for any personnel named in a proposal may result in termination of negotiations.

7. If it is discovered that a selected Offeror is in arrears on taxes due the State of Alaska, a contract may not be awarded until the Alaska Department of Revenue approves the payment provisions for the contract.

8. **Offerors and proposed subcontractors shall be in compliance with the statutory requirements for Alaska business licensing and professional registrations included in the certification statement on Page 2 of Part D in this RFP package. Non-compliance shall result in rejection of proposal.**

9. **PRICE COMPETITION:** Price cannot be an Evaluation Criterion in accordance with Article 3 of AS 36.30 for services that must be performed only by Architects, Engineers or Land Surveyors (A/E or LS) licensed in the State of Alaska, UNLESS the provisions of AS 36.30.270(d) apply; i.e., unless the services required are repetitious in nature, and the nature and amount of services required are thoroughly defined by measurable and objective standards to reasonably enable firms or persons making proposals to compete with a clear understanding and interpretation of the services required. If price is a factor, a majority of the evaluation committee must be registered in Alaska to perform architectural, engineering, or land surveying services.

- 9.1 If the services performed do not require an A/E or LS, then all Offerors including any A/E or LS must provide Price Proposals in accordance with AS 36.30.270(b) and 2 AAC 12.260(c).

SECTION I - TECHNICAL PROPOSAL

1. Objectives and Services

1. Weight: 20

Response must **demonstrate your comprehension of the objectives and services** for the proposed contract. Do not merely duplicate the Statement of Services provided with this RFP. Also, consider if Statement of Services is sufficiently explicit; are expressed or implied schedules attainable/economically feasible; etcetera? Explain. **Define any assumptions made** in formulating Criteria Response. If design services for a construction project are included, express any opinions regarding alternative design considerations that could impact construction costs.

2. Methods

2. Weight: 15

Response must outline the methods for accomplishing the proposed contract or, if methodology is contained in the proposed Statement of Services, address its adequacy. Describe what, when, where, how, and in what sequence the work will be done. Address how proximity to the Project site, *particular* geographic familiarity, experience, and capabilities of your firms (Offeror and Proposed Subcontractors) and Project Staff might *specifically* contribute to the proposed methods.¹ Identify the amount and type of work to be performed by any Subcontractors. Consider how each task may be carried out; what services or interaction required from/with the Contracting Agency; etcetera. Suggest alternatives, if appropriate. Identify any **distinct and substantive qualifications** for undertaking the proposed contract such as the availability of specialized equipment or unique approaches or concepts **relevant to the required services** which the firms may use.

3. Management

3. Weight: 0

Response must describe the administrative and operational structures that will be used for performing the proposed contract. For example consider: who will have overall responsibility for the contract? Who will have direct responsibility for specific disciplines? What will the lines of authority be? For any individual who would be in "responsible-charge" (reference AS 08.48) as an Architect or Chemical, Civil (including Structural), Electrical, Mechanical, Mining or Petroleum Engineer, or Land Surveyor, so state and list his/her Alaska professional registration number. A graphic depiction is preferred in your response to this criterion. Additionally, the Contracting Agency may want to inspect work products in progress and have a close ongoing working relationship with your Project Staff. 4. Permitting and environmental analysis

Describe the work to be performed by the individuals you name to perform essential functions and detail their specific qualifications and **substantive experience directly related to the proposed contract**. A response prepared specifically for this proposal is required. Marketing resumes often include non-relevant information which may detract from the evaluation of proposal. Lists of projects are not useful. Focus on individual's specific duties and responsibilities and how project experience is relevant to the proposed contract.

For each person named, identify their: employer, professional discipline or job classification and state of residency. List at least 3 professional references (contact persons and telephone numbers) for each person.

5. Workload and Resources

5. Weight: 5

Response must: (1) discuss both current and potential time commitments of your proposed Project Staff to all clients; (2) discuss the projected workload of each firm (Offeror and Proposed Subcontractors) for all clients; and (3) demonstrate adequate support personnel, facilities and other resources to provide the services required. Provide a list of current contracts with the Contracting Agency in which your proposed Project Staff are participating. Include all contracts statewide with regions, divisions, etc., of the Contracting Agency.

Briefly address capabilities for providing additional services and/or services under an accelerated schedule. Address capacity to reassign personnel, equipment and facilities whenever the proposed contract would not require such capabilities or was delayed.

6. Past Performance

6. Weight: 15

Response must describe previous projects the project team has worked on that are related in size and scope to this project. Describe the dollar amount of the projects and a brief narrative of the successes of the projects. Address how the experience will help your team to perform under this contract. Provide references (contact name and phone number) for each project. Indicate which of the proposed firms and project staff was involved in each project. The State reserves the right to investigate referenced projects, contact references and research other projects that the respondent has worked on.

7. Quality of Proposal

7. Weight: 5

Offerors do not respond to this criterion. Committee members will rate this criterion based on their perception of the clarity, completeness and presentation of submittal. Note: This criterion is **NOT** used to evaluate color, graphics or other visual techniques except as they may detract from legibility.

8. Marine Structures**8. Weight: 20**

Response must demonstrate the proposed team's experience with the design, permitting and construction of marine structures similar in design and location to the proposed project. Only experience with boat launch ramps and floating structures intended for use by small recreational boats (i.e. less than 26 feet in length) is relevant to this project.

ARTICLE D2 INSURANCE

IHPC 21-001 Scope of Services

Introduction

This is a cooperative project between the Alaska Department of Fish and Game, Division of Sport Fish (Sport Fish) and the City of Saxman (City). Sport Fish will provide the design standards and administer the design process for the project and will fund this portion of the project from its Recreational Boating Access Program. Sport Fish will also provide a portion of the project funding for construction activities. The City will provide any remaining funding needed for project construction of the improvements and maintenance of the completed facility.

Recreational Boating Access is one of the programs administered by Sport Fish. This program provides funds to build boating facilities throughout the state. Although a wide variety of projects can be undertaken through the Sport Fish access program, the primary beneficiary of every project must be the recreational boating public. This program is funded through the Federal Aid in Sport Fish Restoration Act which is commonly referred to as the Dingell-Johnson/Wallop-Breaux Act.

The design of Sport Fish funded boat ramps and boarding floats has evolved over time. Previous boat ramp and boarding float projects funded by Sport Fish in Kake and Seward contain the design elements that Sport Fish prefers to use on this project. The Saxman Seaport is located on the west side of Revillagigedo Island, two miles south of Ketchikan on the South Tongass Highway and is a part of the Ketchikan Gateway Borough (Appendix A). The Saxman Seaport was historically a railroad terminus and barge landing and is in the process of being renovated into a modern small boat harbor. The City project is broken down into three phases: Phase I is now complete and included the construction of a small boat harbor; Phase II will be the construction of a single-lane boat ramp with associated boarding float; and Phase III will be the renovation of the upland area with parking and a small RV park.

The primary objective of this portion of the project is to design and construct Phase II of the Saxman Seaport renovation project. In order to meet the primary objective, this project will construct a single-lane concrete-plank boat ramp and an ADA-accessible boarding float. The boat ramp and associated boarding float shall be designed to service recreational boaters at the Saxman Seaport for a minimum of twenty years. Boat launch parking area improvements, including asphalt paving, may be included as a part of this project as an additive alternative.

This project will be a cooperative effort between Sport Fish and the City. Sport Fish will select the design consultant and administer the consultant contract. The City will administer the construction contract. Sport Fish will be solely responsible for obtaining environmental clearance for the project from the U.S. Fish and Wildlife Service (USFWS), which may require additional services from the consultant. The construction work will be competitively bid and awarded to a private construction contractor.

Services Required

The City completed a preliminary design concept for the project in 2017 and has conducted environmental work for the Saxman Seaport Public Marina Improvement Project in order to receive a Community Development Block Grant to fund the previous construction of the small boat harbor. This work included permitting required for the boat launch ramp. They have obtained some of the permits necessary to construct the launch facility, in addition to holding public scoping events. Unfortunately, the previous design does not meet the Recreational Boating Access Program's design criteria. The consultant will be tasked to revise the preliminary design and permitting/NEPA compliance in order to incorporate the Recreational Boating Access Program's design criteria. It is likely that the revised design will require a modification to existing permits/NEPA compliance documents.

The consultant shall propose a scope of services that will accomplish the objective of this project in a cost effective and timely manner. Work will be divided into two phases. Phase I will provide a preliminary design and all permits and approvals necessary to construct the project. Sport Fish may require (and pay for) additional assistance in complying with the National Environmental Policy Act (NEPA) process in order to obtain USFWS approval of the project. Phase II will carry the project through to completion. In preparing a proposal, the consultant may consider the following list of services.

Phase 1:

- Site investigation.
- Alternative analysis.
- Public involvement.
- Environmental documentation (if required).
- Preliminary design and cost estimate.
- Approvals and permits.

Phase 2:

- Final design and cost estimate.
- Construction document preparation.
- Services during bidding and construction.
- Project close-out.

The consultant may propose to add or delete services if doing so would be appropriate and useful for completing the project. The consultant's fees for services will **not** be a selection criterion but will be negotiated after selection.

Professional Experience and Registration

The consultant shall be a firm that regularly engages in engineering investigation and design services for marine construction of recreational boat launch facilities. The individual in responsible charge of the work shall be a professional engineer licensed in the State of Alaska at the time the proposal is submitted. A minimum of five years of experience in similar work is required.

Schedule

The desired schedule is to have the design services completed by winter of 2021/2022, the construction documents ready for bid solicitation by spring of 2022, and (depending on funding availability) the construction contract awarded by summer/fall of 2022. Construction would begin in fall 2022 with completion by the spring 2023. The consultant shall either confirm that this schedule is feasible or explain why it is not feasible and propose an alternative schedule. A bar chart schedule is not required in the proposal.

Environmental Documentation

Sport Fish funding for this project is 75% federal funds from the USFWS. Therefore, the requirements of NEPA; the Endangered Species Act (16 U.S. Code Chapter 35, 1531-1544); and, the National Preservation Act Of 1966 (Section 106) must be met and in conformance.
