The Department of Law has reviewed the attached regulations of the Department of Health and Social Services against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Health and Social Services after the close of the public comment period. The regulations clarify the conditions under which a tribal clinic that enrolls as a federally qualified health center (FQHC) for purposes of Medicaid reimbursements, and that receives reimbursements under Medicaid provisions for tribal health programs--also known as tribal health organizations (THOs)--may continue to offer identified covered services outside the "four walls" of the clinic's fixed, brick-and-mortar site.

Please note that the adoption order sets a special effective date of November 1, 2021 for the regulations. Accordingly, we request a filing date for the regulations on or before September 30, 2021.

The June 17, 2021 public notice and the September 22, 2021 adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

- 7 AAC 140. Medicaid Coverage; Facility and Facility-Based Services, is proposed to be changed as follows:
  - Amend to exclude or partially exclude a tribal organization that enrolls as a FQHC; identify coverage and requirements for screening and brief intervention services; and identify covered services and payment conditions for a THO that enrolls as a FQHC.
- 7 AAC 145. Medicaid Payment Rates, is proposed to be changed as follows:
  - o Amend to exclude a THO that enrolls as a FQHC.
