Changes to the ITB:

Change 1: SEC. 2.18 CONTRACT PRICE ADJUSTMENTS

ORIGINAL WORDING: "NOTE: Since there is no published OPIS Daily gross rack average for Heating Oil and Jet A in the Seattle OPIS location, the contractor shall use the Jet A price published in the daily OPIS West Coast Spot Market Report, Pacific Northwest, for Heating Oil and Jet A deliveries."

REPLACE WITH: DELETE original wording as listed above from ITB. Add two new locations on the bid schedule titled ITB 2022-0200-4928 – Bid Schedule (Land). The two new locations are for OPIS prices in Los Angeles and the PNW.

Change 2: ITB 2022-0200-4928 – Bid Schedule (Land)

ORIGINAL WORDING: The Fairbanks Jet-A fuel OPIS number was listed as \$2.4715, which is a typo.

REPLACE WITH: Updated with correct value of \$2.4725.

<u>Change 3: ITB 2022-0200-4928 – Bid Schedule (Land)</u>

ORIGINAL WORDING: The OPIS Price Locations and Evaluation Prices had only 3 locations: Seattle, Fairbanks, and Anchorage.

REPLACE WITH: Added 2 new price locations: Los Angeles and PNW. Added OPIS prices to those locations, bidders can now use them for bidding within the Bid Schedule spreadsheet. Los Angeles does not have pricing for ULSD and Unleaded currently, therefore they are left blank intentionally.

<u>Change 4: ITB 2022-0200-4928 – Bid Schedule (Land)</u>

ORIGINAL WORDING: The OPIS price for Heating Oil in Anchorage is set to \$2.3100, which differs from the Jet A price. For bidding purposes only, this should be the same as the Jet A fuel cost for Anchorage, since they are the same for all other locations.

REPLACE WITH: Changed the Heating Oil price for Anchorage from \$2.3100 to \$2.2425.
