The Department of Law has reviewed the attached regulations of the Department of Public Safety against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The Department of Public Safety adopted the regulations after the close of the public comment period. These amendments are made to 13 AAC to set standards for the use of all-purpose vehicles. These standards include a 45 mile per hour limit on applicable roadways, establishing light, brake, throttle, and other equipment safety standards, and defining "all-purpose vehicle" under 13 AAC 40.010(a)(67).

The Feb 10, 2021 public notice states that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.
