3. VENDOR QUESTION:

Do you require items to be produced in the USA?

DOC RESPONSE:

No, products are not required to be produced in the USA. The successful contractor can source the materials and supplies outside the USA as long as they meet the minimum item specifications described on the Bid Schedule.

4. VENDOR QUESTION:

What lead time for delivery would you expect after a Purchase Order is issued?

DOC RESPONSE:

The maximum expected delivery time is 30-45 calendar days after a Delivery Order or Purchase Order is issued by the ordering facility.

5. In the ITB, on Page 8, SEC. 1.16 is replaced with:

The bidder(s) are required to submit samples. The samples should contain one (1) of each of the items offered for inspection and application. Bidders are allowed to submit samples in a form of fabric and material swatches with their bids. All final samples must be submitted before the Notice of Intent to Award, and must be delivered to the address as shown below:

6. VENDOR QUESTION:

In the past the state purchased GRAY wool blankets, would color gray be acceptable or it has to be White in color?

DOC RESPONSE:

Preferred color: White; second option: Gray; third option: Light Blue. Any other light colors are acceptable to submit for samples and will be reviewed. See Amended SEC. 1.16 regarding submission of samples.
