QUESTIONS AND ANSWERS

**Question #1: How many Biomass applications submitted for the current round?**

**Answer #1:** *2 biomass applications has been received for a total grant request of \$1.5 million*

**Question #2: What was the breakdown, by technology, with respect to the applications?**

**Answer #2:** *Biomass: 2; Heat Recovery: 1; Hydroelectric: 7; Solar: 9; Energy Storage: 4; Wind: 13; Other: 3*

**Question #3: What was the total number of applications received for the current round?**

**Answer #3:** *Alaska Energy Authority received 39 applications for the Round 14 solicitation period, ending on January 18th, 2022. The total grant monies requested was \$19.2 million. It was estimated that approximately 30 applications, upon conclusion of stage 1 REF eligibility determination by Alaska Energy Authority staff, It will be submitted for economist evaluation.*

**Question #4: Has the REF economic evaluation model changed in any material way?**
