

## Safety Net Service Codes and Rates

All Crisis Services are defined in the Alaska Administrative Services Standards Manual for Behavioral Health and Alaska Administrative Services Standards Manual for SUD.

Safety Net crisis services must be provided in accordance with 7 AAC 138 and 7 AAC 139.

Continuity of Care services has been included in the Safety Net Services and is not in the Alaska Administrative Services Standards Manuals. This service allows the provider to meet the requirement and best practice in crisis service delivery to provide the follow up encounter (s) with individuals to ensure the situation remains stable and the individual is linked to appropriate outpatient treatment and or community support services as indicated.

T2034 V2  Mobile Outreach Crisis Response MOCR	1 call out at \$175.64	MOCR are provided to prevent substance use disorder or mental health crises from escalating; stabilize an individual during or after a mental health crisis or crisis involving a substance use disorder; or refer and connect to other appropriate services that may be needed to resolve the crisis.	1 per individual per episode of care
H0038 V2  Peer Based Crisis Services	15 minutes = 1 unit  \$20.46 per unit	Provided by a peer support specialist under 7 AAC 138.400 to help an individual avoid the need for hospital emergency department services or the need for psychiatric hospitalization through triage of crisis intervention needs; facilitation of transition to other community-based resources or natural supports and advocacy for client needs with other service providers.	24 units per individual per episode of care
S9484 V2  23 Hour Crisis Observation Services (COS)	60 minutes = 1 unit  \$116.20 per unit	COS are intended to provide prompt observation and stabilization services to individuals presenting with acute symptoms of mental or emotional distress. May only be provided up to 23 hours and 59 minutes in a secure and protected environment that must- be provided by	23 units per individual per episode of care

		physician or a physician assistant or advanced practiced registered nurse staff supervised by a physician. Must coordinate with law enforcement and have capacity to receive direct referrals from law enforcement.	
S9485 V2 Crisis Residential and Stabilization Services	\$900.00 per day	A medically monitored, short term, residential program in an approved facility that provides 24/7 psychiatric stabilization.	7 days per individual per episode of care
ISA-SNCC Continuity of Care Services	15 minutes =1 unit \$21.46	This service includes outreach via telehealth or in person for follow up to ensure the individual is connected to the necessary community outpatient treatment or support services to maintain stabilization.	24 units per individual per episode of care

There are no limits on the number of episodes of care as it is possible a client may have numerous episodes.

\*Episode of care is defined as one encounter from date of admission or start of service to discharge date. For example, an episode of care is for a client admitted into 23 Hour Crisis Observation on 12/23/21 and discharged on 12/24/21. \*
