The Department of Law has reviewed the attached regulations of the Department of Labor and Workforce Development against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Labor and Workforce Development after the close of the public comment period and concern amending 8 AAC to update training requirements, certificate of fitness application processes, continuing education requirements, definitions, and adoption of the current edition of the *National Electrical Code*.

A number of technical edits are suggested to provide consistency and to conform these regulations to the standards of the Drafting Manual for Administrative Regulations. Of note, an amendment to 8 AAC 90.162(a) has been included to conform a cross-citation to the newly renumbered definition section under 8 AAC 90.900. None of the edits are substantive in nature.

The September 21, 2021 public notice and the January 25, 2022 adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

BRIEF DESCRIPTION

The Department of Labor and Workforce Development, Mechanical Inspection, proposes to change regulations in Title 8 of the Alaska Administrative Code, dealing with updating methods of applications, definitions, and processes.

The Department of Labor and Workforce Development proposes to adopt regulation changes in Title 8 of the Alaska Administrative Code, dealing with updating methods of applications, definitions, and processes, including the following:

- 8 AAC 61.855 is proposed to be amended to update the method of application to current standards and update the form of the certificate.
- 8 AAC 70.025 is proposed to be amended for periodic adoption of the latest National Electrical Code, 2020 edition.
- 8 AAC 90.110 is proposed to be repealed and readopted to update the process of obtaining an application for certificate of fitness.
