

Notice of Pipeline Carrier Tariff Filing

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that Oliktok Pipeline Company (Oliktok) filed TL48-334, a revenue requirement study based on a 2021 test year.

With TL48-334, Oliktok proposes a 45 percent increase to its intrastate natural gas transportation rates from the Prudhoe Bay Unit to the Milne Point Production Pipeline Connection and a 47 percent increase to its intrastate natural gas transportation rate from the Prudhoe Bay Unit to the Kuparuk River Unit, effective May 1, 2022. Oliktok states that it is not seeking a rate design and to the extent that a cost-of-service study is required, it requests a waiver of 3 AAC 48.275(h) to the extent that additional information, outside of what is provided in testimony, is required. A comparison on the current and proposed rates are shown in the table below.

Prudhoe Bay Unit	Milne Point Pipeline Connection	\$0.38/mscf	\$0.56/mscf

Oliktok requests that should the Commission not grant permanent approval of its proposed rates for natural gas service, Oliktok requests that the rates be approved on a temporary and refundable basis.

This notice may not contain all requested revisions and the Commission may approve a rate or classification, which varies from that proposed.
