1. The following changes were made to the Bid Schedule Lot #1. Please see the attached ITB 2023-2000-5160 Bid Schedule – AMD #1
 - a. Lines 2, 2.1, 3, 3.1, 4 and 4.1 – Brand and model specified have been discontinued. Upgrade or recommended replacement by the manufacturer will be accepted.
 - b. Line 18 – Size XS is removed.
 - c. Line 27.2 - added Size: L – 5X TALL
 - d. Lines 28 and 28.1 – Updated correct manufacture number for the TDU Green color: 72194
 - e. Line 33 - Size XS is removed.
 - f. Line 36.2 – added Size: 5X – 6X for Black and Navy color only
 - g. Line 36.3 – added Size: L – 6X TALL for Black and Navy color only
 - h. Line 39 - Size XS is removed.
 - i. Line 39.1 – added Size 4X – 6X
 - j. Line 39, 39.1, 40 and 41 - Brand and model specified have been discontinued. Upgrade or recommended replacement by the manufacturer will be accepted.
 - k. Line 40 - This item does not come above size 2X. Sizes 3X is removed.
 - l. Line 40.1 - This item does not come above size 2X. This line is removed in its entirety.
 - m. Line 43 – This item has been discontinued. Other brand and model offered will be reviewed.
 - n. Line 49.1 – Other brand and model offered will be reviewed.
2. The following changes were made to the Bid Schedule Lot #2. Please see the attached ITB 2023-2000-5160 Bid Schedule – AMD #1
 - a. Line 1 – Flight Suit. This line item is removed in its entirety.
 - b. Line 10 – Goggles. This line item is removed in its entirety.
 - c. Lines 12 – Elbow Pads. Color Olive Drab is removed. Other brand and model offered will be reviewed, Black in color.
 - d. Line 13 – Knee Pads. Color Olive Drab is removed. Other brand and model offered will be reviewed, Black in color.

- e. Line 21 – Flex Cuff Cutter. Other brand and model offered will be reviewed.
- f. Line 26 – Tourniquet. Updated the part numbers specific for color Black (#30-0001) and Orange (#30-0023).
- g. Line 27 – Tourniquet Holder. Updated the part numbers specific for color OD (#30-0053) and Black (#30-0057).
- h. Line 28 – Gunshot Trauma Kit added.

NOTE: Bid Schedule AMD #1 Lot #2 item numbers were adjusted according to the changes above and has a total of 29.5 items.

3. Vendor Question:

- Do any of the items in Lot 2 require customization, such as emblem application, embroidery, or screening? If yes, would you please confirm the customization required?

DOC Response:

No. Customization such as emblem, embroidery or print screen is not required for any of the items in Lot #2.

4. Vendor Question:

- The vest on Line 6 of Lot 2 is not available in sage – the available colors are black, navy, tan, and white. Will the tan color meet your needs, as the manufacturer states this is the closest option to sage?

5. Vendor Question:

- Line 16 of Lot 2, the requested part number is from 5.11 Tactical and the requested brand is Blackhawk. Would you please clarify the specific product you need?

DOC Response:

Requested brand is Blackhawk Quick Release Pouch, #37CL116.
