**The following are vendor questions and the department's response:**

1. Vendor: I will say slightly disappointed with the scope change regarding paving. We have done quite a bit of homework and have a solid paving plan (not to mention the quantity of paving mentioned in the question was significantly off). I would doubt you would reconsider at this late a date, but we do think leaving the trench/partial road unpaved is not a great solution. I would caution VSW that it appears some bidders will not have strong abilities to solve this paving scope even if pursued as a change order post award.

Department: The department is amending the responses to Amendment 5, questions #3 and #4 to the following:

Additive Alternate #1 shall include all surface paving requirements specified in the Invitation to Bid. Bidders shall use the attached revised bid schedule for submitting a bid. If the department does not award Additive Alternate #1, then the department may choose to bid this work separately or utilize force account labor for this work.
