Chapter 44. Board of Nursing.

The emergency amendment of 12 AAC 44.305(a)(1)(E) is made permanent to read:

(E) attestation of 320 hours of nursing-related employment in the five years immediately before the date of application;

The emergency amendment of 12 AAC 44.305(a)(4) is made permanent to read:

(4) a reference letter from the applicant's past employer verifying that the applicant has been employed in a nursing capacity for at least 320 hours within the last five years before application; if the applicant has not worked within the preceding five years, the applicant must submit proof of meeting the continuing competency requirements of the board or complete a course of study approved by the board.
