RFQ TITLE: 10-002-23 As Needed Warm Storage of DOF Fire Engines

RFQ DEADLINE FOR RECEIPT OF QUOTES: 2:00 p.m. on September 2, 2022 (Unchanged)

1. Amendment One changes the RFQ deadline for receipt of questions, makes changes discussed in number 2, 3, 4, and 5, and addresses questions asked by an offeror on August 16, 2022.
2. The deadline for receipt of questions has changed from 1400 AKST on August 23, 2022, to 1400 AKST on August 26, 2022.
3. **Add** to RFQ 10-002-23, Contract Prices: DOF will provide the vendor with an inventory of confirmed engines to be stored by Sept. 1 of each contract year. This will guarantee storage space for all confirmed vehicles and constitute DOF's obligation for that contract year. All confirmed/guaranteed vehicles will have a billable term from October 1 through April 30 of each contract year, regardless of delivery date, with the option to extend month-to-month if weather does not permit removal of units prior to April 30. Any additional engines identified after September 1 will be treated on a first-come, first-served basis and billed at the same rate as the confirmed/guaranteed engines.
4. **Change** to RFQ 10-002-23, Scope of Work: "The State will guarantee a minimum of ten (10) engines per contract year".
5. **Change** to RFQ 10-002-23, Quote Submittal: "The State will guarantee a minimum of ten (10) engines per contract year".
6. **Question:** Knowing the exact number of engines on September 1st is extremely helpful as it allows us to plan around our other customers and properly manage our facility. One of the issues that arose last year is that we ended up storing less engines than anticipated at the beginning of the storage season and turned away other business as we were extremely full – and then the engines didn't show. To resolve this, I would suggest a start date, i.e., October 1st, and have a guaranteed spot for all "confirmed" engines. We can confirm anywhere from a minimum of 10 total engines to the entire fleet at Forestry's discretion the first week of September. Any confirmed engine will begin the rent clock on 10/1 and will be charged for the full season regardless of move-in/move-out dates.

Answer: DOF has agreed to guarantee a minimum of ten (10) engines each contract year as reflected in lines 4 and 5 of this amendment. Total number of confirmed engines will be provided to the vendor by DOF by September 1 of each contract year. Additional engines identified after the Sept. 1 deadline will be subject to availability and will be billed at the confirmed/guaranteed rate. DOF also agrees to a billable service term as outlined in line 3 of this amendment.
