- 4. Approval of agenda; Kendra Kloster moved, Heather Gottshall seconded, all in favor; approved.
- 5. Approval of minutes from August 9, 2022 council mtg: Malia Miller moved to amend the roll call, she was listed as present but she was absent; Lydia Heyward moved to approve pending the change.
- 6. New Business: Vice Chairwoman opened up conversation regarding meeting invites and set-up issues to figure out where the disconnect is. There's been difficulty finding public notices, meeting dates, and minutes.

Expressed her gratitude that the Governor is recognizing the MMIP issues and that it needs to be addressed. She wants every indigenous voice to be heard and their wounds to be addressed. She links colonialism and the residential boarding school institutions to the trauma. Encourages the council to be familiar with the federal residential board school institutions which are tied to MMIP.
