## Home and Community Based Waiver and Personal Care Target Provider August 1, 2022 List

Each August 1, per 7 AAC 145.531(b), the Department will publish a list of target providers on the department's website and on the Alaska Online Public Notice System. Providers identified on this list will be required to submit an annual report within 8 months of their fiscal year end for the fiscal year that ends during the calendar year in which the list is published. The Department will list if the annual report is a full annual report or a reduced annual report.

The August 1, 2022 list was determined by using claims data for dates of services July 1, 2020 through June 30, 2021, which represents the most recent state fiscal year for which timely filing has passed. Target providers are determined by the Medicaid units of service that was paid during the applicable time period. For each service category, the lessor of the top five providers in terms of units of service or the number of providers it takes to achieve 90% of all Medicaid paid units of service are selected.
