#### **EMERGENCY SPILL RESPONSE CONTRACTORS**

#### Introduction:

The State of Alaska, Department of Environmental Conservation (from now on referred to as "DEC" or "Department") is requesting information from vendors available statewide and regionally within the state able to provide timely response and emergency dispatch to mitigate, contain, control, cleanup, remove, and dispose of oil and hazardous substance releases. Hazardous substances may include crude oil, products refined from crude oil, hazardous substances and materials, unknown and uncharacterized substances, contaminated debris, contaminated soil, and related waste materials.

This Request for Information (RFI) does not guarantee future work. The information will aid the Division of Spill Prevention and Response; Prevention, Preparedness, and Response Program (PPR) in conducting market research to ascertain available contractors throughout the state's regions. This information will provide a real-world understanding of potential vendors to allow the Department to rapidly access the services of contractors with particular specialties in oil spill response in the event of a release or threatened release, enabling more rapid response in the event of an emergency or emergent event.

### **Response Information:**

This RFI aims to identify viable resources and compile a comprehensive list of responsive vendors. Respondents should include the following information:

- 1. Name, address, telephone number, and preferred point of contact (POC) of the firm
- 2. Region(s) serviced within Alaska (i.e., Interior, Southeast, statewide)
- 3. Existing capacity of workers, equipment, and services
- 4. Approximate timeline to mobilize response (i.e., 24-hour notice, three days, two weeks)

The proposed list will encompass stakeholder-specific needs, which may require content variations depending on the Department's requirements.

The PPR Program is requesting the above information from respondents to this RFI. If the services described previously can be provided, please submit a response to this RFI by Friday, December 30, 2022. The answer must include details of previous experience and qualifications for hazardous materials containment, examples of the services provided to other customers, and why the respondent's services will work for the state.

The information provided in the RFI is subject to change and is not binding on the Department. The Department has not committed to procuring any of the services discussed. Releasing this RFI should not be construed as a commitment or authorization to incur a cost for which reimbursement would be required or sought. All submissions become the Department's property and will not be returned.
