ORDER ADOPTING CHANGES TO REGULATIONS  
OF THE DEPARTMENT OF REVENUE

The attached one page of regulation, dealing with Permanent Fund Dividend electronic signature requirements, is adopted and certified to be a correct copy of the regulation changes that the Department of Revenue adopts under the authority of AS 09.80.150, AS 43.23.015, and AS 43.23.055, and after compliance with the Administrative Procedure Act (AS 44.62), specifically including notice under AS 44.62.190 and 44.62.200 and opportunity for public comment under AS 44.62.210.

This action is not expected to require an increased appropriation.

Although no public comments were received, the Department of Revenue paid special attention to the cost to private persons of the regulatory action being taken.

The regulation changes adopted under this order take effect on the 30th day after they have been filed by the lieutenant governor, as provided in AS 44.62.180.
