#### Answers to Questions from Vendors

**Question 1:** Can you provide any information about the suitability of material in the "Mile 136 Pit"?

**Answer:** In August 2022, DNR's engineering consultant noted that the bottom of the material site had excessive fines; however, the site had an upper layer of very clean non-frost-susceptible gravel that should meet spec without issue. It is the contractor's responsibility to ensure road construction materials meet specification.

**Question 2:** Specify the type of Geotextile required in the Pioneer Road Typical #1, sheet 1 of 2, 6.). Please clarify requirement of a Type I, Reinforcement, woven or a Class I, Separation, woven. There is a significant price difference between the 2 types of Geosynthetics. **Answer:** Reinforcement, Woven, Type 1 is intended.

**Question 3:** Pioneer Road Typ. #1 indicates a road TYP disturbance width of 42'. Should that be 32' +/-? Please clarify.

**Answer:** Please see attached revised typical section dated March 6, 2023.

- 1. ROAD IS TO BE CONSTRUCTED TO THE MINIMUM STANDARDS OF A PIONEER ROAD AS DEFINED BY THE MATANUSKA-SUSITNA BOROUGH (MSB).
- 2. ALIGNMENT TO BE CLEARED AND MULCHED TO GROUND LEVEL 40' EACH SIDE OF CENTERLINE USING ROTARY MULCHING EQUIPMENT. DISTURBANCE OF VEGETATIVE MAT TO BE MINIMIZED.
- 3. 36" MINIMUM EMBANKMENT FILL. VOLUME ESTIMATED AT 3.6 CYD / LINEAR FT COMPACTED IN PLACE.
- 4. NO CUT DITCHES TO BE CONSTRUCTED DUE TO EXISTING GROUND CONDITIONS AND MINIMAL TOPOGRAPHIC RELIEF.

- 6. GEOTEXTILE MUST MEET ALASKA DEPARTMENT OF TRANSPORTATION (DOT) SPECIFICATIONS FOR REINFORCEMENT, WOVEN, TYPE 1.
- 7. EMBANKMENT MATERIAL MEET MSB STANDARDS FOR SUBBASE AND BE FREE OF MUCK, FROZEN MATERIAL, ROOTS, SOD OR OTHER DELETERIOUS MATTER; HAVE A PLASTICITY INDEX NOT GREATER THAN 6 PER ATM 204 AND GRADE THE FOLLOWING:
