As this year's regulatory cycle comes to a close, I would like to remind you about the upcoming proposal deadlines for next year's regulatory cycle. I have attached fillable proposal templates with instructions for each board. Proposals can be submitted online, by fax, or by mail. For more information, please visit the [Boards Support website](#) or contact me for assistance.

**The Board of Fisheries** is currently accepting proposals for **Lower Cook Inlet, Kodiak, & Upper Cook Inlet finfish management areas**. The board may also consider **subsistence proposals for other topics (including other areas)** under the subsistence proposal policy, 5 AAC 96.615, if proposals are submitted within this deadline and the board determines they meet the criteria in either 5 AAC 96.615(a)(1) or (2). Please review the [Call for Proposals](#) for more detailed information.

**Proposal Deadline: April 10, 2023.**

**The Board of Game** is currently accepting proposed changes to hunting and trapping regulations for the **Interior, Arctic, & Western** areas of Alaska which covers **Game Management Units 12, 18, 19, 20, 21, 22, 23, 24, 25, and 26**. The board will also consider proposed changes to regulations under 5 AAC Chapter 92, Statewide Provisions that are specific to Game Management Units, excluding changes to Game Management Unit boundaries. **Proposal Deadline: May 1, 2023.**

**The Joint Board of Fisheries and Game** is accepting proposed changes to its regulations pertaining to local fish and game advisory committees and the process for adopting fish and game regulations to be considered at its next regulatory meeting, scheduled for March 2024. Sections of Title 5 Chapters 96, 97, and 99 of the Alaska

2021 sections of Title 5 Chapters 03, 07, and 08 of the Alaska Administrative Code will be considered. Please review the [Call for Proposals](#) for more detailed information.
