In accordance with my authority under AS 44.62.125(b), please forward to the publisher the corrections to the Alaska Administrative Code (AAC) described below. This revision corrects typographical errors in the April 2023 Supplement, Register 244.

The regulations to be revised are located in 12 AAC 14. The revisions to the regulations of that chapter are as follows:

- In the editor's note following 12 AAC 14.300, please add a colon after "Internet address" and a colon after "telephone".
- Please note to the publisher: the lead-in line of 12 AAC 14.430 is incorrectly labeled as 12 AAC 114.430.
- Please correct the language of 12 AAC 14.445(g) to read "performed under (a) of this section" from "performed under (a) this section"
- Please correct the language of 12 AAC 14.500(a)(4) to read "...throughout pregnancy, the intrapartum period, and the postpartum period;" from "...throughout the pregnancy, intrapartum, and postpartum period;"
- Please correct the language of 12 AAC 14.500(a)(17) to read "offer to one or both parents an injection..." from "offer an injection..."
- Please correct the language of 12 AAC 14.500(a)(21) to read "in accordance with regulations under P.L...." from "in accordance with regulations under P.L."
- Please add a close parenthesis after (HIPAA) in 12 AAC 14.500(a)(21).

- Please correct the language of 12 AAC 14.510(b)(3)(A) to read “failure to void within 12 hours of birth;” from “failure to void not later than 12 hours after birth;”
- Please correct the language of 12 AAC 14.510(c)(10) to read “failure to urinate within 24 hours of birth;” from “failure to urinate not later than 24 hours after birth;”
- Please correct the language of 12 AAC 14.510.(c)(11) to read “failure to pass meconium within 48 hours of birth;” from “failure to pass meconium not later than 48 hours after birth;”
- Note to the publisher: The lead-in line of 12 AAC 14.540 is incorrectly labeled as 12 AAC 514.540”
- Please correct the capitalization in the title of 12 AAC 14.600 from “Emergency Practices” to “Emergency practices”.
- Please add a history note after 12 AAC 14.600 to read “(Eff. 5/11/94, Register 130; am 5/2/2004, Register 170; am 9/9/2016, Register 219; am \_\_\_/\_\_\_/\_\_\_\_\_, Register \_\_\_\_\_)”

- Please add the authority citation following 12 AAC 14.600 to read:

- In the editor’s note that follows 12 AAC 14.910 please correct the State Office Building address from “33 Willoughby Avenue” to “333 Willoughby Avenue”.
- Please add an editor’s note following 12 AAC 14.445 to read as follows:
