Mike Questions- If Chignik area management opens up windows to fish pink and chum, what are the chances they would intercept AYK bound chinook and chum?

Gail: my assessment would be that would be very low, area L fish come down in a very localized pattern. Very low chances.

Karma: Not sure how they could manage fishing for pink and chum, if sockeye isnt open and their escapement is unknown.

Steve: My concern would be anything that is opening for commercial, I am not in favor. Ben: Not in support either

Gail Vick: Roadmap for Board mtg. shows 140 as #3 so it will come up very quickly.

Mike Question: 138 Observers- separate from Commercial fishing time.

Gail: Good proposal and we need it, but the board cannot obligate the department to financial obligation, it should go to the legislature.

Mike: How many observers would be required and where would the funding come from? Gail: Quite a few vessels participate. Mostly targeted at the trawl fishery in the Bering Sea pollock fleet. If this went to the Legislature, it would likely be cameras on board each vessel. These boats are not as big as the pollock fleet, but they are still really big boats and they fish 24-7. Concerns about Chum chucking and other practices. Cheaper and would record activity.
