Questions submitted by potential offerors and answers from the Department:

Question 1: On the answer to question 7 it states that positive tests will be sent to the lab for confirmation, so can we assume that the volume chart you attached would result in about 376 tests per month being sent to the lab for confirmation?

Answer: UA Lab test is confirmation; that is the number of tests being sent to the lab.

Question 2: What does the UA Labs/Month represent – are those the items requested by inmates at their cost?

Answer: We did not indicate how many UAs were paid for by offenders.

Question 3: Are the oral tests, lab tests?

Answer: The oral tests are not necessarily lab tests; only if they need confirmation and that was included in the UA lab test number (62).

Question 4: On the new pricing sheet amendment, is the pricing requested a price for confirmations per analyte? And what does "Labs/YR____" mean?

Answer: YES, confirmation. Estimated number of Monthly (*not yearly*) labs for confirmation testing. See updated cost proposal attached.
