

NOTICE OF PROPOSED CHANGES ON ALTERNATING LICENSED PREMISES IN THE REGULATIONS OF THE ALCOHOLIC BEVERAGE CONTROL BOARD

Brief Description: The Alcoholic Beverage Control Board proposes to change regulations in Title 3, Chapter 304 of the Alaska Administrative Code dealing with alternating licensed premises.

The Alcoholic Beverage Control Board proposes to make changes dealing with alternating licensed premises including the following:

3 AAC 304.225 introductory language is amended to expand the license types eligible to apply for alternating licensed premises.

You may comment on the proposed regulations, including the potential costs to private persons of complying with the proposed regulations, by submitting written comments to Alcohol and Marijuana Control Office at 550 W. 7th Avenue, Suite 1600, Anchorage, Alaska, 99501. Additionally, the Alcoholic Beverage Control Board will accept comments by electronic mail at amco.regs@alaska.gov. Comments may also be submitted through the Alaska Online Public Notice System, by accessing this notice on the system and using the comment link. **The comments must be received not later than 4:30 p.m. on June 9, 2023.**

You may submit written questions relevant to the proposed action to Alcohol and Marijuana Control Office by email to amco.regs@alaska.gov or by mail to 550 W. 7th Avenue, Suite 1600, Anchorage, Alaska, 99501. The questions must be received at least 10 days before the end of the public comment period. The Alcohol and Marijuana Control Office will aggregate its response to substantially similar questions and make the questions and responses available on the Alaska Online Public Notice System and <https://www.commerce.alaska.gov/web/amco/>

The language of the final regulation may be different from that of the proposed regulation. You should comment during the time allowed if your interests could be affected.
