Questions submitted by potential offerors and answers from the state:

Question 1: SEC. 3.03 DELIVERABLES and SEC. 7.01 ATTACHMENTS, 5) Submittal Form G – Cost Proposal,

The State requires 5 spare Cameras annually. Will the state require 5 spare signature pads? There is no mention of them in Form G Cost Proposal.

Answer 1: See Change 1: and Change 2: Remove and Replace below.

Question 2: SEC. 4.04 EXPERIENCE AND QUALIFICATIONS (SUBMITTAL FORM B),

Are Offerors to provide Reference Letters or only reference names and phone numbers?

<u>Answer 2:</u> Offerors must provide reference letters.

Question 3: SEC. 4.08 SUBCONTRACTORS (SUBMITTAL FORM F),

If offerors did not plan to have any subcontractors prior to award, will the offeror be allowed to use Subcontractors after award?

Answer 3: No, subcontractors must be identified on the offeror's proposal Submittal Form F.

Question 4: SEC. 5.10 ALASKA OFFEROR PREFERENCE,

Can the State confirm that a bidder holding a valid Alaska business license at the time of submission of the proposal is entitled to receive the Preference?

Answer 4: These requirements are detailed in SEC. 6.12 ALASKA BIDDER PREFERENCE, page 34 of the RFP.

Question 5: SEC. 5.10 ALASKA OFFEROR PREFERENCE,

Can the State please confirm that a bidder claiming 10% preference as defined under RFP SEC 5.10 does not require filling out the Alaska Bidder Preference Certification AS 36.30.321(a) / AS 36.30.990(2) – provided as an attachment to the RFP?

<u>Answer 5:</u> To claim any preference, the proposal must include the Alaska Bidder Preference Certification Form.

Question 6: SEC 6.12 ALASKA BIDDER PREFERENCE,

Can the State confirm this Bidder Preference is in addition to the 10% preference defined under SEC 5.10?

Answer 6: No, the 5% Alaska Bidder Preference is applied to the cost and the 10% Alaska Offeror Preference is added to the overall points.

Question 7: Submittal Form G Cost Proposal,

Are "One Time Fees"" going to be milestone payments?

Answer 7: See Change 3: Remove and Replace below.
