NOTICE OF PROPOSED CHANGES TO BUSINESS SIGNS AND PROMOTIONAL ADVERTISEMENT IN THE REGULATIONS OF THE MARIJUANA CONTROL BOARD

Brief Description: The Marijuana Control Board proposes to change regulations in Title 3, Chapter 306 of the Alaska Administrative Code dealing with business signs and promotional advertisement.

The Marijuana Control Board proposes to make changes dealing with business signs and promotional advertisement including the following:

- 3 AAC 306.310(b)(3) proposes to amend prohibited marketing promotions.
- 3 AAC 306.770(b) proposes to remove certain restrictions on business signs and allow for local government enforcement.
- 3 AAC 306.770(f) proposes to amend restrictions on advertising.
- 3 AAC 306.770(g) proposes to amend font visibility for advertisement of warnings.
- 3 AAC 306.770(k) proposes to remove the restriction of using giveaway coupons for marijuana or marijuana product as promotional material, and holding promotional activities outside of the marijuana licensed premises.

You may comment on the proposed regulations, including the potential costs to private persons of complying with the proposed regulations, by submitting written comments to Alcohol and Marijuana Control Office at 550 W. 7th Avenue, Suite 1600, Anchorage, Alaska, 99501. Additionally, the Marijuana Control Board will accept comments by electronic mail at amco.regs@alaska.gov . The comments must be received not later than 4:30 on July 21, 2023.

You may submit written questions relevant to the proposed action to Alcohol and Marijuana Control Office by email to amco.regs@alaska.gov or by mail to 550 W. 7th Avenue, Suite 1600, Anchorage, Alaska, 99501. The questions must be received at least 10 days before the end of the public comment period. The Alcohol and Marijuana Control Office will aggregate its response to substantially similar questions and make the questions and responses available on the Alaska Online Public Notice System and https://www.commerce.alaska.gov/web/amco/
