The following contains additional information, changes, or additions for the RFQ:

- 1) Beginning on Page 10 of the RFQ paragraph 1.41 (More Than One Bid Submission) is amended to read and show as follows:

**1.41 MORE THAN ONE BID SUBMISSION**

Bidders may only submit one bid in response to this RFQ. If a Bidder submits more than one bid in response to this RFQ, all bid submissions from that Bidder will be considered non-responsive to the RFQ.

- 2) The following questions or comments were received by the Procurement Manager from potential Offerors:

- i. **Question:** *Were we required to be at the meeting and walk-through that happened on August 11<sup>th</sup> to be considered for the bid?*

**Response:** No, although the Agency encouraged potential bidders to attend in person or call into the teleconference, the pre-proposal teleconference and site visit were optional for bidders to attend or call into.

- ii. **Question:** *Will the existing window cranks be changed to accommodate the blackout style window shades or would you like to consider changing the mount position to external mount?*

**Response:** The Agency is working with the renovation contractor to source a folding window crank style to replace all the existing window crank handles. The shades will be internal mount style.

iii. **Question:** *Would you like to consider using the LightLock tracks that mount into the window frame and provide a guide for the shades that eliminate light from entering through small cracks?*

**Response:** No, the Agency has chosen not to pursue the design changes needed to include the LightLock track.

3) All other terms and conditions of RFQ 665 will remain as written.

To be considered responsive to this RFQ each Bidder shall submit a signed copy of this Amendment No. 1, in addition to the Offerors Bid. All signed and completed documents must be received by the issuing office prior to the opening date and time.
