Notice of Utility Tariff Filing

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that G & K, Inc. (G&K) filed TA200-88, a revenue requirement study based on a 2022 test year. With this filing, G&K proposes an interim and refundable across-the-board rate increase of 50.8 percent, effective September 11, 2023. G&K further requests a permanent rate increase of 67.7 percent, to be effective upon completion of the rate case.
