Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulations of the Board of Psychologists and Psychological Associate Examiners against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Board of Psychologists and Psychological Associate Examiners after the close of the public comment period.

The regulations concern the establishment of new telepsychology standards of practice and application requirements for courtesy licenses. The public notice for the regulations also contained changes to the continuing education requirements for psychologists and psychological associates, however, the board withdrew those changes following public comment and only adopted the telepsychology and courtesy license provisions.

The adopted regulations provide eligibility requirements and define the scope of services for delivering psychological service while physically separate for the recipient through electronic means. In addition, the adopted regulations require applicants for a courtesy license to be licensed in another jurisdiction where the licensing requirements are at least equivalent to the licensing requirements in Alaska.

The July 12, 2023 public notice and the August 24, 2023, certification of adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

No technical corrections were necessary to conform the regulations in accordance with AS 44.62.060.

The attached four pages of regulations relating to application requirements for courtesy licenses, and establishing new telepsychology standards of practice are certified to be a correct copy of the regulation changes that the Board of Psychologist and Psychological Associate Examiners adopted at its August 18, 2023 meeting, under the authority of AS 08.01.062, AS 08.86.070, AS 08.86.080, AS 08.86.085, AS 08.86.130, AS 08.86.160 AS 08.86.170, and AS 08.86.204 and after compliance with the Administrative Procedure Act (AS 44.62), specifically including notice under AS 44.62.190 and 44.62.200 and opportunity for public comment under AS 44.62.210.

This action is not expected to require an increased appropriation.

On the record, in considering public comments, the Board of Psychologist and Psychological Associate Examiners paid special attention to the cost to private persons of the regulatory action being taken.

The regulation changes described in this order take effect on the 30th day after they have been filed by the lieutenant governor, as provided in AS 44.62.180.

Chapter 60. Board of Psychologist and Psychological Associate Examiners.

12 AAC 60.035(c)(4) is amended to read:

(4) provide verification of a current license in good standing to practice psychology independently in another jurisdiction where the licensing requirements are at least equivalent to those in this state for the scope of practice specified in the application; to meet the requirements of this paragraph, the verification must be sent directly to the department from the licensing jurisdiction and the license must [BE ACTIVE, IN GOOD STANDING, AND] cover the scope of the practice requested for the courtesy license in this state; (Eff. 2/27/2005, Register 173; am 8/23/2009, Register 191; am 10 / 18 / 2023, Register 248)

12 AAC 60.400. Scope of telepsychology practice. (a) Services offered by licensees by electronic means who are physically separate from the recipient of the services fall within the jurisdiction of the board.

(b) The standards of traditional face-to-face services described in AS 08.86 and 12 AAC 60 apply to telepsychology or technology-assisted distance professional services.

(c) The practice of technology-assisted distance professional services does not include functions or practices that are not within the training required for licensure under this chapter in accordance with AS 08.86.164 and 12 AAC 60.180.

(d) The scope, eligibility, and standards of telepsychology practice established under 12 AAC 60.400 - 12 AAC 60.415 do not supersede the functions, practices, and definitions relating to “appropriate supervision” and “supervised experience” as described elsewhere in AS 08.86 and this chapter. (Eff. 10 / 18 / 2023, Register 248)

(1) be licensed under AS 08.86.130 as a licensed psychologist or under AS 08.86.160 as a licensed psychological associate; and

(2) complete general competency training in the practice of telepsychology, totaling a minimum of four hours. (Eff. 10 / 10 / 2023, Register 248)

Licensees are required to comply with all statutes, regulations, and rules of the state where the client is physically located. (Eff. 10 / 10 / 2023, Register 248)

be, understandable by the recipient, discuss the benefits and risks of entering into distance professional services, and address the use of telephone, online synchronous provision of psychological services, electronic billing, text, and email contact with a recipient. (Eff.
