## NOTICE OF PROPOSED CHANGES ON OVERLAPPING PREMISES IN THE REGULATIONS OF THE MARIJUANA CONTROL BOARD

Brief Description: The Marijuana Control Board proposes to change regulations in Title 3, Chapter 306 of the Alaska Administrative Code dealing with overlapping premises.

The Marijuana Control Board proposes to make changes dealing with overlapping premises including the following:

- 1) 3 AAC 306.705 section heading wording is proposed to be amended to clarify that the section deals with licenses premises.
- 3 AAC 306.705(d) is proposed to be amended to clarify that overlapping premises that are restricted access areas may be approved by the board if the requirements of 3 AAC 306.710(d) are met.
- 3) 3 AAC 306.710(d) is proposed to be amended to update language in conformance with the changes to 3 AAC 306.710(d).

You may comment on the proposed regulations, including the potential costs to private persons of complying with the proposed regulations, by submitting written comments to Alcohol and Marijuana Control Office at 550 W. 7<sup>th</sup> Avenue, Suite 1600, Anchorage, Alaska, 99501. Additionally, the Marijuana Control Board will accept comments by electronic mail at amco.regs@alaska.gov. Comments may also be submitted through the Alaska Online Public Notice System, by accessing this notice on the system and using the comment link. The comments must be received not later than 4:30 pm on November 13, 2023.

You may submit written questions relevant to the proposed action to Alcohol and Marijuana Control Office by email to amco.regs@alaska.gov or by mail to 550 W. 7<sup>th</sup> Avenue, Suite 1600, Anchorage, Alaska, 99501. The questions must be received at least 10 days before the end of the public comment period. The Alcohol and Marijuana Control Office will aggregate its response to substantially similar questions and make the questions and responses available on the Alaska Online Public Notice System and https://www.commerce.alaska.gov/web/amco/

After the public comment period ends, the Marijuana Control Board will either adopt the proposed regulations or other provisions dealing with the same subject, without further notice, or decide to take no action. The language of the final regulation may be different from that of the proposed regulation. You should comment during the time allowed if your interests could be affected.
