Dear Lieutenant Governor Dahlstrom:

We have reviewed the attached regulations of the Department of Law against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Law after the close of the public comment period.

The regulations concern the representation of certain executive branch officials in proceedings related to the Alaska Executive Branch Ethics Act. This regulation will authorize the Department of Law to defend and represent the Governor, Lt. Governor, or Attorney General in proceedings before the State Personnel Board alleging ethical violations.

The August 4, 2023, public notice and the October 12, 2023, adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

We have made some technical corrections to conform the regulations in accordance with AS 44.62.060. The corrections are incorporated into the attached copy of the regulations.

The section heading of 9 AAC 52.140 is changed to read:

9 AAC 52.140. Complaints; legal representation.

9 AAC 52.140 is amended by adding new subsections to read:

- (f) If a person brings a complaint alleging a violation under AS 39.52.110 39.52.190 or this chapter by the governor or the lieutenant governor, the Department of Law may provide legal representation if the attorney general certifies that the representation is in the public interest. For complaints against the attorney general, the governor may certify that representation by the Department of Law is in the public interest. For the purpose of this subsection, "public interest" includes whether the action taken is within the scope of the official's duties.
- (g) Notwithstanding the certification under (f) of this section, the governor, lieutenant governor, or attorney general may decline representation by the Department of Law and hire private counsel.
- (h) Information received by the Department of Law that is related to the defense of a complaint under this section is confidential and not subject to disclosure, absent a court order or a release of information. (Eff. 4/24/94, Register 130; 12/22/2010, Register 196; am
